This is a Supplementary Product Disclosure Statement ('SPDS') for the FirstChoice Wholesale Personal Super and Pension Product Disclosure Statement – Issue No 2016/1, dated 16 May 2016 ('Original PDS') and the FirstChoice Wholesale SPDS dated 4 October 2016, issued by Colonial First State Investments Limited ABN 98 002 348 352 AFS Licence 232468.

The purpose of this SPDS is to establish the AZ Sestante options as part of the FirstChoice Wholesale Personal Super and Pension product range.

# **AZ Sestante Wholesale options**

The AZ Sestante Wholesale Conservative, AZ Sestante Wholesale Diversified and AZ Sestante Wholesale Growth options each have exposures to multiple underlying funds that, together, comprise the assets of each AZ Sestante investment option. These underlying funds may pay a performance fee to the underlying investment manager of up to 30% for absolute performance or performance above a benchmark such as the S&P/ASX 300 Accumulation Index or the Reserve Bank of Australia (RBA) cash rate. Such performance fees may be calculated before or after the deduction of management fees depending on the underlying fund. The effect of any performance fees paid by the underlying fund is reflected in the return of the allocation that the AZ Sestante option makes to each underlying fund, and this will result in a reduction of the investment performance for the AZ Sestante option. The allocation to underlying investment funds with or without performance fees may change at any time without notice to investors. No performance fees are paid to AZ Sestante.



# Example - performance fees for AZ Sestante Wholesale Diversified

Assuming three of the underlying investment managers in the option make up 5% each in the total allocation, and achieve the below:

Investment manager 1: 3% return and applies a 20% performance fee on absolute return.  $(3\% \times 5\% \times 20\%)$ 

Investment manager 2: 3% return above RBA Cash rate and applies a 20% performance fee. (3% × 5% × 20%)

Investment manager 3: 2% return above S&P/ASX 300 Accumulation Index and applies a 30% performance fee. (2% × 5% × 30%)

The option would effectively incur 0.08% in performance fees  $(3\% \times 5\% \times 20\%) + (3\% \times 5\% \times 20\%) + (2\% \times 5\% \times 30\%)$  which would reduce the investment performance of the 15% allocation made by the AZ Sestante Wholesale Diversified option by this amount.






